Racism and racial discrimination are social realities that affect all areas of life.

Racist remarks, acts and behaviours do not necessarily occur frontally and directly. Racism can also be encountered in our everyday life, "under the form of subtle racial discrimination acts, such as being ignored, ridiculed or treated differently".

Discrimination may affect:

- Access to employment, dismissals;
- Access to private goods and services (housing, loans, leisure activities);
- Access to public services (education and training).

It is important to know and assert your rights. It is also important to report a racist or discriminatory situation, when you are facing one.

HOW TO DEAL WITH A SITUATION OF RACISM **OR RACIAL DISCRIMINATION?**

Are you a **victim** or **witness** of racist remarks or acts? Do you feel that you have been discriminated because of your origin, your religious background or the colour of your skin, by an individual, an association, a company, or a public service?

You can contact the service of intercultural cohesion (service de la cohésion multiculturelle - COSM) to receive information, advice and orientation.

The collaborators of the COSM are at your disposal to:

- Provide support and listening
- Identify a situation of discrimination
- Provide information and advice on possible legal actions
- Provide administrative support
- Propose mediation

All individuals who have been a victim or witness of racism and/or discrimination can benefit from a consultation, regardless of their residence status. Consultations are free and confidential, and an interpreter can assist you if needed.
